How tonight's results will be used

Varsity. No team will be eliminated from contention from the championship based on tonight's results alone. The second meet will split the varsity teams into a 6-team Varsity A field and a 4-team level Varsity B field. Only A-level teams will advance to the top "Varsity A" bracket.

All division champions--based on winning percentage, then points/game, then points/tossup--will advance to Varsity A along with three wildcard teams. *Note that head to head results will not be used to determine wildcards or other seeding.* These teams will play a round robin bracket designed to minimize repeat of tonight's matches. These team's combined statistics (for the first two meets) will be used to award them the top 6 seeds for the March championship.

At the second meet, Varsity B will play a round robin bracket. The top 2 teams from Varsity B will also advance to the March championship bracket. The other teams from Varsity B will play exhibition matches in March.

Exhibition teams will play in a similar elimination bracket at the next meet with seeding based on tonight's results. The top 8 exhibition teams based on the results from the second meet will advance to the exhibition championship bracket.
