## East Lincoln High School Campus Parking Lot Rules 2023-2024

East Lincoln High School students that choose to drive to school must park in the student parking lot **ONLY**. Parking a private vehicle on campus is a privilege granted to students. To keep that privilege, students must obey all rules and regulations concerning the operation of a motor vehicle on campus and traveling to and from the Lincoln County School of Technology. Students who do not drive are subject to fines for violations of the parking lot rules when in the student parking area. Only currently enrolled students are allowed in the student parking area. Students under suspension and visitors are not allowed in the student parking area without prior permission. Unauthorized persons on campus may be charged with trespassing. Students may lose parking privileges for the following reasons:

1. Failure to purchase and properly display parking permit by hanging permit from the rear view mirror, facing forward.
2. Lending parking permit to another or placing permit in a vehicle not registered with the school.
3. Any violation of the North Carolina Motor Vehicle Law including exceeding safe speed, equipment violations, safety inspection or violation of any other law pertaining to the operation of a motor vehicle.
4. Possession of alcohol or any controlled substances anywhere on campus.
5. Remaining in the parking lot after arrival to school, or remaining in the parking lot after 3:15 p.m. unless participating in a school-sponsored activity. Loitering in the parking lot area will not be tolerated. Students must enter school immediately upon arrival.
6. Failure to pay fees or fines within five (5) school days.
7. Parking in other than assigned parking space between the hours of 7:00 a.m. and 3:15 p.m. without prior approval from a staff member or the School Resource Officer.
8. Driving the wrong way, against arrows; failure to stop for stop bars and signs; driving left of double yellow lines; or failure to obey or tampering with any traffic control device.
9. Cruising the parking lot. When entering the parking area, students must go directly to their parking space. When leaving the parking area, students must leave the parking area by going directly to a parking lot exit.
10. Exceeding school posted speed limit of 15 MPH.
11. Parking in such a manner as to cause parking problems for other students, such as parking over the lines for the assigned space.
12. Any violation of North Carolina law in or about the student parking area, such as larceny, hit and run, intentional damage to a vehicle, disorderly conduct, fighting, loud music or engine noise, etc.
13. Unauthorized presence in the school parking lot during school hours. Students may not go to vehicles or be in the student parking area without authorization from the office.
14. Other violations as determined by the administration or School Resource Officer.
15. **Eight tardies to class or school will result in the loss driving privileges for the remainder of the semester. No refunds will be given.**

### Consequences For Not Properly Displaying Parking Permit

1 <sup>st</sup> Offense	Documented Warning
2 <sup>nd</sup> Offense	Documented Warning
3 <sup>rd</sup> Offense	Loss of Driving Privileges for 10 School Days
4 <sup>th</sup> Offense	Loss of Driving Privileges for 20 School Days
5 <sup>th</sup> Offense	Loss of Driving Privileges for 30 School Days
6 <sup>th</sup> Offense	Loss of Driving Privileges for 60 School Days
7 <sup>th</sup> Offense	Loss of Driving Privileges for the Rest of the School Year

Any citation or arrest issued by a law enforcement officer on or about the school campus, traveling to or from LCST, or possession of alcohol or any controlled substance anywhere on school property (including LCST) will result in an immediate 30-day or more suspension of parking privileges and a school fine in addition to disciplinary consequences as stated in this handbook.

Parents and others bringing or picking up students must drop off or pick up students in the front circle. The only exception to this is students riding with other students who are parking on campus.

For the safety of all students, parking lot rules and regulations will be strictly enforced. The school administration reserves the right to deny parking privileges for recurring rules violations. If a student drives to school after having a parking permit revoked, his/her car will be towed. That student will be responsible for all fees and fines charged by the tow company. Oversized vehicles, generally vehicles larger than a full sized standard pick-up truck, will be required to park next to the tennis courts.

**East Lincoln High School is a Drug and Tobacco Free campus.  
A vehicle on campus may be searched without due warning.**



### Consent Form Participation in the Drug-Testing Program

This form must be completed and signed by each high school student who holds a campus parking pass, student athletes, and his/her parent or legal guardian. This form is required for all students who hold a campus parking pass or participate in any athletic competition, to include cheerleading. Eligibility for campus parking privileges and athletic participation will not be granted until this form has been signed and returned to the student's school.

#### Drug-Testing Consent

By signing this form, I, the undersigned student and parent, affirm that I am aware of the Lincoln County Board of Education's drug-testing regulations and procedures, which requires the following for any student who holds a campus parking pass and student athlete who is found to have any tested drug or substance:

- A first positive test may result in a ninety (90) day period of ineligibility from campus parking privileges and student athletics. Prior to returning to campus parking privileges and athletic participation, the student must provide a negative drug test result. The cost of the follow-up drug test is the responsibility of the student.
- A second positive test may result in a 365 day period of ineligibility from campus parking privileges and student athletics. Prior to returning to campus parking privileges and athletic participation, the student must provide a negative drug test result. The cost of the follow-up drug test is the responsibility of the student.
- A third positive test may result in permanent ineligibility from campus parking privileges and student athletics for the remainder of the student's career.
- **Any student who has a positive drug test will forfeit eligibility for a parking pass and/or athletic participation.**

I hereby give consent to be tested by an independent, licensed drug-test administrator for the presence of illegal drugs and controlled substances if I am randomly selected, or if there is a reasonable suspicion or cause for a test, or a follow-up test is required for participation in campus parking and student athletics. I consent to giving a urine specimen or saliva test for testing upon request by the drug-test administrator. I understand that a refusal to be tested, or any attempt to tamper the test sample will result in a declaration of a positive test. I agree to follow the drug-testing procedure that has been set forth in Board Policy 3623-R/4343-R.

I hereby authorize the licensed physician to release the results of my test to the student's parent/guardian and the Superintendent or her designee, who shall notify the student's principal, athletic director and coach. I waive any privilege in connection with the results of the drug test. I understand that the drug-test results will not be shared with law enforcement and that the outcome of the drug test will not affect my academic career.

By signing this form, I have read and understood Board Policy 3623-R/4343-R and its related consequences. I understand that the Lincoln County Board of Education and its officers, administrators, employees, and agents are hereby released from legal responsibility or liability for the release of such information and records as authorized by this form.
